Reimagine the Cross Bronx

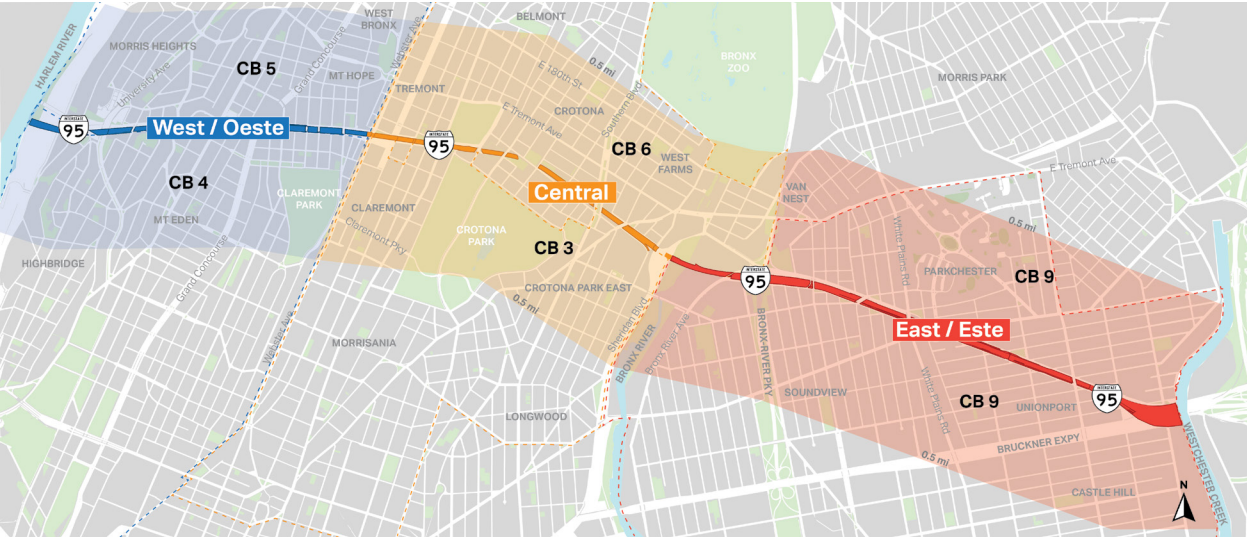


Project Overview

New York is developing a community-driven vision to Reimagine the Cross Bronx and reconnect neighborhoods along the Cross Bronx corridor from the Harlem River to the Hutchinson River Parkway, including the East, Central, and West sub areas.

This project is a partnership between the New York City Department of Transportation (NYC DOT), the NYC Department of City Planning (NYC DCP), the NYC Department of Health and Mental Hygiene (DOHMH), and the New York State Department of Transportation (NYSDOT). Collectively the four partner agencies are referred to as the Project Team.

We will continue to look to the diverse communities in the study area, to offer input and feedback, identify and prioritize issues, then develop and refine solutions and recommendations.

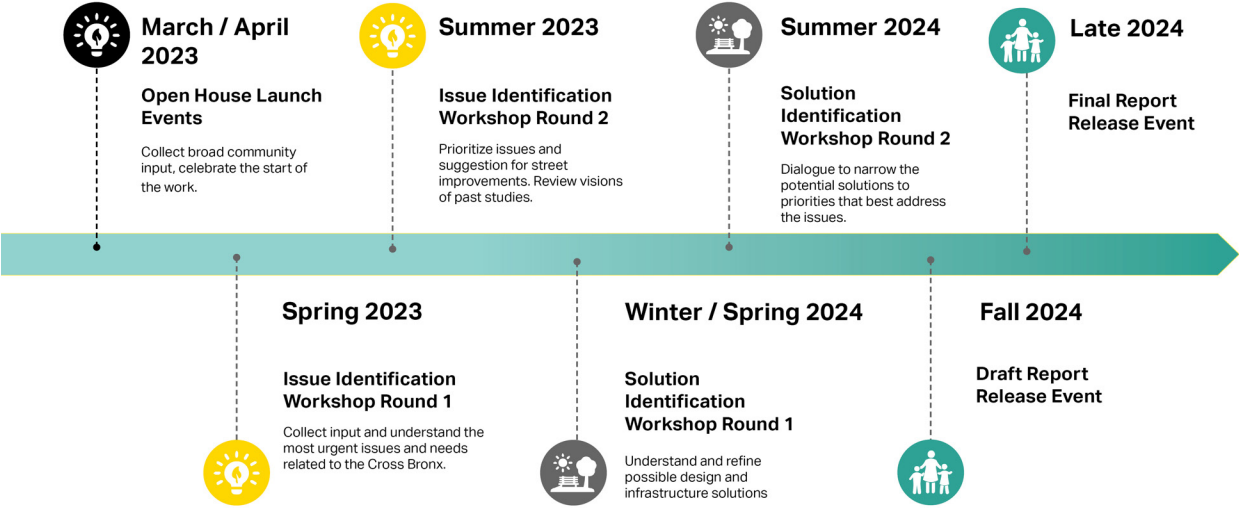
Public Involvement

The **Reimagine the Cross Bronx** study engages communities along the Cross Bronx corridor to identify issues and potential solutions in multiple touch points and activities. The first round of public engagement held between March 30th and April 4th, comprised a series of five open houses both virtual and in-person.

In addition, the Project Team holds periodic meetings with the Community Working Group (CWG), a set of community and civic stakeholders who advise on the study and serve as ambassadors to their Bronx communities. A Community Partner Program will be launched to fund local organizations to help the study reach diverse communities along the Cross Bronx.

Issue Identification Workshops are planned for Spring and Summer 2023, Solution Identification workshops in Winter, Spring and Summer of 2024, and events for the draft report release and final report release later in 2024.

What we heard

Open Houses & Participants' Feedback

The virtual open house sessions were held on March 30 and April 10, from 6 pm to 8 pm, while the in-person open house sessions were held on Saturday, April 1, from 11 am to 2 pm at Bronx River Art Center (West Farms); Monday, April 3, from 6 pm to 9 pm at Davidson Community Center (Morris Heights); and Tuesday, April 4 from 5 pm to 8 pm at PS 106 Parkchester Elementary School (Parkchester).

These open houses launched the public involvement process and provided an opportunity for public input, questions, and comments. Approximately 250 members of the public attended the public open houses, and more than 500 comments were collected. Translation services were offered in Spanish, French, Bengali, and ASL interpretation.

The variety of activities offered at the open houses and community participation provided relevant feedback, which has been synthesized into several main categories.

The main comments were related to:

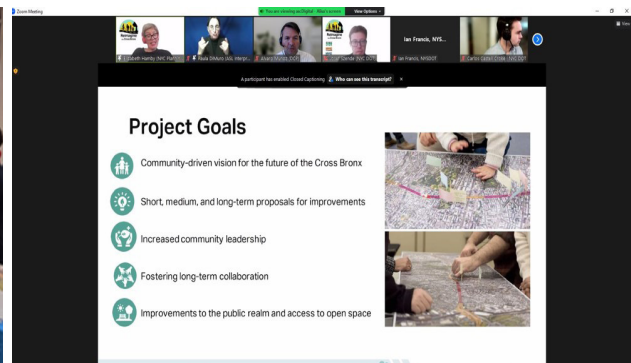
- **Community Assets Identification**

Virtual Open Houses on March 30, and April 10, 2023

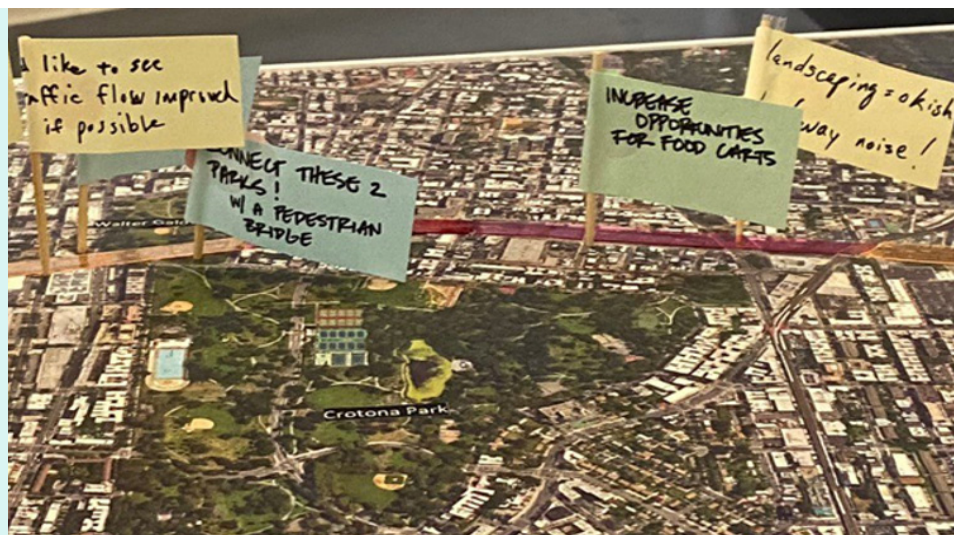
What we heard

Community Assets Identification

Using community mapping activities, participants were able to identify more than 25 community assets, landmarks, and programs around the Cross Bronx that are relevant to the community and should be considered when developing the study. Below is a summary of the locations identified during the open houses. Additional outreach opportunities will seek to continue gathering community-based landmarks and relevant location points throughout the corridor.

- **Educational facilities and programs** include P.S. X811 at Longfellow Ave, 180th St Day Care, Daily UPIC Program (University Professional Internships), Wings High School, Lebanon UPK Program (Universal Pre-K), MS 118 William Niles School, Bronx Community College, and Job Corps.
- **Cultural centers and community centers** include the Bronx River Art Center (BRAC), Davidson Community Center, Kips Bay boys and girls club, Police Athletic League (PAL) youth development not-for-profit)
- **Open Space and recreational facilities** include, Virginia Park and Train station, Hunts Point Market, Pedestrian Bridge Riverside Park, Starlight Park, Tennis courts, Handball courts, Drew Gardens educational recreation space, Richmond Echo Park, Yankee Stadium, Walter Gladwin Park, and Crotona Park
- **Health facilities** include Morris Heights Health Center and DOHMH Bureau of Bronx Neighborhood Health
- **Faith-based facilities** include Nazareth Pentecostal Church and Iglesia Mission Juan 3:16

Participants were encouraged to pinpoint issues and opportunities during during the in-person open house using the Experience Collector Map.

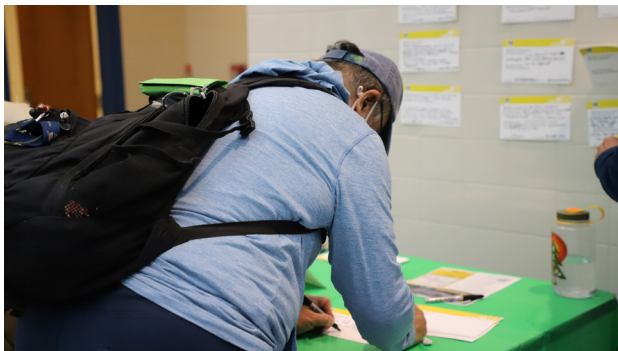
Open Space, Beautification, and Connections

Feedback organized into the Open Space, Beautification, and Connections category included requests for pedestrian connections, capping the Cross Bronx, better waterfront access, lighting, green space, and trash management. Key takeaways are:

- Explore the feasibility of capping trenched sections of the Cross Bronx. Consider capped sections to include parks and open spaces, pedestrian and bicycle connections across the highway, and community facilities.
- Connect neighborhoods and improve both North/South and East/West pedestrian connectivity, including waterfront access, and open space continuity. Participants highlighted access to Harlem River Greenway and Bronx River Parkway, and connecting Walter Gladwin Park and Crotona Park.
- Incorporate green spaces outside the Cross Bronx right-of-way. Participants mentioned opportunities for a terraced park on the steep terrain near the George Washington and Alexander Hamilton Bridges, upgrades to Jenny Jerome playground, a dog park near Parkchester, and urban farming or garden opportunities on Shakespeare Avenue.
- Invest in beautification efforts such as waste management, lighting upgrades, and tree planting.

What we heard

Air Quality, Noise, and Traffic Congestion

Feedback organized into the Air Quality, Noise, and Traffic Congestion category included comments on the Cross Bronx environmental externalities, such as pollution and traffic, as well as broader policy goals. Key takeaways are:

- Analyze the effects of nearby truck routes on air quality
- Explore short-term solutions to improving air quality, such as distributing filters to communities near the Cross Bronx. Asthma is a significant concern among communities surrounding the Cross Bronx, and numerous commenters reported purchasing air filters and frequently replacing them to improve indoor air quality.
- Explore solutions to reduce traffic on the Cross Bronx Expressway, and discourage through-travellers from using local roads to avoid congestion
- Reduce traffic, congestion of local roads, noise, and pollution. Residents living around the Cross Bronx are not necessarily the main users of the expressway but are the most impacted.
- Consider tolling and other demand-management tools, such as congestion pricing, to reduce the overall traffic on the Cross Bronx.

Community Wellbeing

Feedback organized into Community Wellbeing included comments on investment toward urban design solutions and building healthier environments. Key takeaways are:

- Increase tree planting and shaded areas to improve the air quality and recreation space of neighborhoods surrounding the Cross Bronx.
- Explore opportunities to ensure fresh food options, urban farming, and EV charging stations.

What we heard

Public Transit, and Safety

Feedback organized into Public Transit, and Safety category included requests for improved transit, bicycling and pedestrian connections, and safety improvements to roadway geometry and lighting. Participants highlighted the difficulty of travel across the Cross Bronx due to congestion and shared the following key takeaways:

- Consider tolling and other demand-management tools.
- Improve east-west transit and bike/ped transportation across the corridor.
- Explore additional bicycle and pedestrian connections, considering north-south and east-west connectivity.
- Explore alternative modes of freight transportation.
- Introduce other public transit options to redesign the Cross Bronx, such as light rail and Bus Rapid Transit, bicycle greenways and busways.

Housing, Social and Economic Development

Feedback organized into the Housing, Social and Economic Development category focuses on creating opportunities for Cross Bronx communities through the corridor’s visioning, programming, and broader policy choices.

- Look for ways to incorporate spaces for businesses, especially those selling local and fresh goods, and food trucks, in the new corridor design.
- Focus on hiring locally when possible for the work, and protect businesses that hire Bronxites.
- Increase density around transit nodes in the surrounding region, including housing development and green spaces with indoor structures for community and local orgs, education, and recreation programming.

What we heard

- Housing affordability and displacement of residents and communities. Participants would like to see policies and strategies to prevent gentrification and displacement.
- Concerns regarding impacts to homes sitting on the service road of the Cross Bronx.

Environmental Justice

Feedback organized into the Environmental Justice category focuses on the lasting harm the Cross Bronx has left on nearby communities and ways to improve the health, access to opportunities, and built environment.

- Support investment in the community surrounding the Cross Bronx, affected by lack of connectivity, frayed social fabric, reduced opportunity, and hostile design.
- Ensure public meetings for visioning the future of the Cross Bronx are inclusive and planned through an equity framework.
- Focus on neighborhood security, clean air, and pedestrian safety to uplift a sense of pride and community.

Governance, Communication, and Community Input

Feedback organized into the Governance, Communication and Community Input includes multiple requests for a transparent, community-based and straightforward public input process.

- Highlight cultural and community resources, parks, and open spaces on public involvement maps.
- Explore a 3D model, walking tours, and other activities for public involvement.
- Provide more information on public policies, as well as resources and points of contact, and information regarding the roles of different agencies.

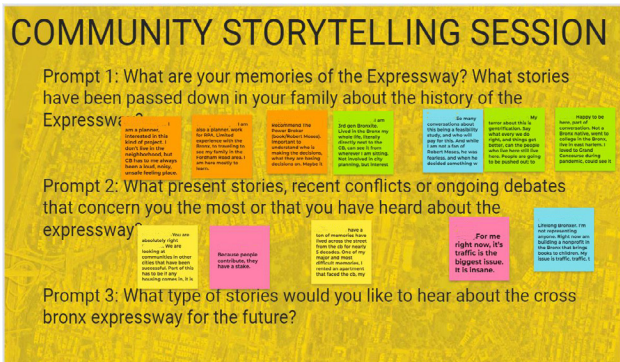


Participants shared their experiences at the storytelling comment station.

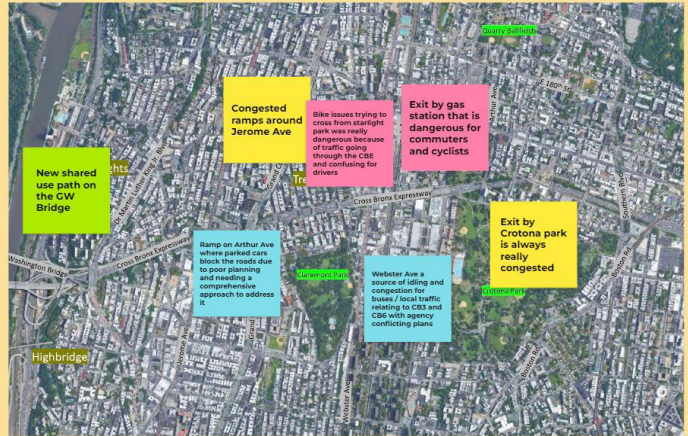

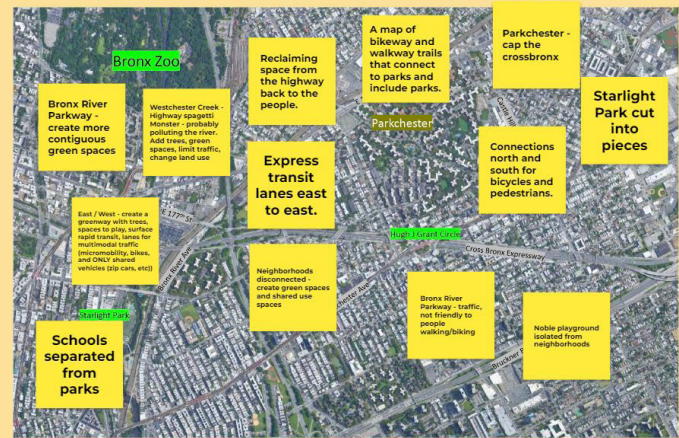

In Winter/Spring/Summer 2024, the Project Team will hold two solution identification workshops to share preliminary conceptual short-, medium- and long-term proposals for community feedback. Throughout this process, the Project Team will continue to engage the Community Working Group, Community Partners, and focus groups to expand engagement reach.
